### **CONSIGNOR INFORMATION**

Registered horses run in sequential order. They will run through the sale first and grades will follow. There is a \$50 catalog and online advertising fee (non-refundable), which is to be paid when consignment form and copy of registered papers are submitted. Should the consignor own a registered horse and opt to not submit it in the catalog, they will run with the grades after the registered horses run.

Consignment forms are due 2 weeks prior to the sale by 2pm. (ex: Sat. April 14 consignment papers are due Sat. March 31<sup>st</sup> by 2pm)

Any horse that enters the ring and does not sell will be charged a \$40 "No Sale" fee.

There is a \$5.00 yardage fee for first day, \$10.00 a day after that for the first week, and \$20.00 thereafter.

If any horse does not sell in the ring there is a "NO SALE" fee of \$40 per horse. Any horse that sells under \$500 has a flat commission fee of \$40 and any horse that sells for more than \$500 will pay 8% of the final bid taken on the horse.

The morning of the sale consignors must check in horse with the office. There must be an original coggins within 6 months of the sale date. **NO COGGINS LATER THAN 6 MONTHS OF SALE DATE AND NO COPIES OF THE COGGINS WILL BE EXCEPTED.** If the horse is registered, the original registration papers and transfer papers must be turned in also. A Crowley employee will then check in your horse and place assigned stickers on hips, which can be reserved when you present paperwork ahead of time. Please be ready at time of sale as the horses will go in order **NO EXCEPTIONS.**

Grade horses are permitted to be advertised in catalog and online same as registered by paying \$50 non-refundable fee.

I agree to follow the policies the Crowley's Sales Barn and Stables upholds including:

1. \$50 non-refundable entry fee per horse which gives Consignor a number, a catalog spot, and information to be placed on our website should consignor advertise.
2. Consignor will present original COGGINS TEST within 6 months of sale date, also registered horses will have registered papers and transfer papers on sale date.
3. Consignor will pay \$5.00 per horse for a yardage fee on sale day.
4. Consignor will have horse prepared for the slot given so auction will not be held up. If consignor is not prepared, Crowley's Commission Sales will admit horse in sale ring at their discretion.
5. Consignor settles up after horses run through auction. If "no sale" consignor will pay a \$40 "no sale" fee per horse. If they sell for under \$500 they will pay a flat fee of \$40. If they sell for more than \$500, consignor will pay 8% of the final bid taken on the horse. This will be deducted from the check.
6. If horse is sold as sound, check will NOT be given the day of sale. It will be issued 72 hours after the sale to address above, giving time for buyer to vet check the horse.
7. Any serious irregularities or unsoundness of any kind shall be furnished to the sale management, including cribbing, bleeder, HYPP horses, and the right to announce such finding is hereby granted.
8. The consignor has the right to "No Sale" their animal only while it is still in the ring if the amount bid is not acceptable. The owner cannot No Sale the animal once it has left the ring.
9. The consignor agrees to transact all business through the SALE OFFICE whether the animal is sold before, during, or after the sale on that sale date. If you are found to not have conducted your transaction through the office the seller will be charged twice the amount of the normal commission, and the purchaser will also be charged 8% of the selling price.
